

**NOTICE OF REFERENDUM  
WESTBY AREA SCHOOL  
DISTRICT APRIL 4, 2023**

**Referendum Election Details**

At an election to be held in the Westby Area School District on April 4, 2023, the following proposed Revenue Limit Resolution of the School Board will be submitted to a vote of the people:

**RESOLUTION AUTHORIZING THE SCHOOL DISTRICT BUDGET TO EXCEED  
REVENUE LIMIT BY \$1,900,000 PER YEAR FOR THREE YEARS FOR NON-  
RECURRING PURPOSES**

BE IT RESOLVED by the School Board of the Westby Area School District, Vernon, La Crosse and Monroe Counties, Wisconsin that the revenues included in the School District budget be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,900,000 per year for three years beginning with the 2024-2025 school year and ending with the 2026-2027 school year, for non-recurring purposes to sustain educational programs and to operate the District.

**Ballot Text**

The question will appear on the ballot as follows:

"Shall the Westby Area School District, Vernon, La Crosse and Monroe Counties, Wisconsin be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,900,000 per year for three years beginning with the 2024-2025 school year and ending with the 2026-2027 school year, for non-recurring purposes to sustain educational programs and to operate the District?"

**Explanation**

The referendum election ballot will ask District electors to vote "yes" or "no" on the referendum election question as set forth above.

A "yes" vote on the question is a vote to authorize the Westby Area School District budget to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,900,000 per year for three years beginning with the 2024-2025 school year and ending with the 2026-2027 school year, for non-recurring purposes to sustain educational programs and to operate the District.

A "no" vote on the question is a vote to deny the Westby Area School District the authority to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,900,000 per year for three years beginning with the 2024-2025 school year and ending with the 2026-2027 school year, for non-recurring purposes to sustain educational programs and to operate the District.

In the event a majority of the electors voting on the question vote "yes", the District will be authorized to exceed the revenue limit specified in Section 121.91, Wisconsin Statutes, by \$1,900,000 per year for three years beginning with the 2024-2025 school year and ending with the 2026-2027 school year, for non-recurring purposes to sustain educational programs and to operate the District; if a majority vote "no" on the question set forth above, the District will not be so authorized.
