**Minutes of Committee on Transit and Active Transportation, November 13, 2025**

**Minutes of the meeting of the CTAT** held in-person and as a virtual meeting on Teams on Thursday, November 13, 2025, at 3:30 pm.

**1) Approval of the minutes of the September 11, 2025, CTAT meeting.**

**2) Review and Ranking of Transportation Alternatives Program (TAP) Applications**

Erin Duffer informed attendees about the purpose and process of ranking TAP applications. Scoring sheets distributed to voting members of the committee, excluding those that have submitted TAP applications.

*Nikki Kvam presenting the La Crosse County Safe Routes to School (SRTS) Application:* La Crosse County applied for non-infrastructure TAP funds to support ongoing Safe Routes to School planning and event organizing in addition to supporting a new initiative to engage high-school students with the program.

*Kevin Schubert presenting the City of Onalaska STH 16 Project:* This application is to complete the last portion of the STH 16 shared-use path County Road PH and South Kinney Coulee Road.

*Bob Stupi presenting the Town of Holland MH Trail Phase 2 Project:* This application is to fund the last portion of the MH separated trail between County Road XX and Sunrise Lane.

*Jenna Dinkel presenting the City of La Crosse Ranger Drive Project:* This application is to retrofit Ranger Drive to feature grade-separated bike lanes on both sides and safe crossing improvements.

*Jenna Dinkel presenting the City of La Crosse King Street Project:* This application is to complete the King Street Greenway between 3<sup>rd</sup> and 7<sup>th</sup> street.

Committee members reminded to submit their completed scoring sheets to Erin Duffer by the following Monday at 5pm.

**3) RTA Feasibility Study Update**

LAPC recommended a special CTAT meeting take place in January or December to have a presentation from SRF about the RTA Study. Members were informed that LAPC and SRF staff are meeting with the steering committee next week.
