The City of Onalaska is proposing to install a sidewalk connection along East Avenue between Century Place and Oak Park Drive. This sidewalk is a vital link between the Village of Holmen/Town of Onalaska and the City of Onalaska. This final sidewalk connection would be the only North/South pedestrian route between these municipalities. This sidewalk connection would allow pedestrians from the North to access the La Crosse Area YMCA – Onalaska campus, Onalaska Omni Center, Onalaska School District athletic fields, Onalaska pool, etc. This project has been included in the proposed City of Onalaska Capital Improvements Budget for four consecutive years but has not been funded. This connection has been requested by various residents for a North/South pedestrian movement.


This Project will narrow the street from the current 42-foot face to face to approximately 32-foot face to face. The current westerly curb and gutter will be removed and approximately 1,700 lineal feet of new curb and gutter will be installed along with paving of the street to the current centerline. New roadway striping will be installed with narrower driving lanes. The new sidewalk will utilize the vacated street space to allow installation of a sidewalk due to challenges with adjacent properties driveway grades and home elevations. The narrowing of the roadway would act as a traffic calming measure, slowing traffic and lowering vehicle emissions. The sidewalk connection will allow more pedestrian to walk to functions and events and thereby reducing vehicle trips.
