Regarding: Clinical Supervision within the Comprehensive Community Services

Included below is a list of potential providers willing to contract services to agencies for Clinical Supervision within WRIC CCS. These practitioners currently work with CCS and understand the CCS Philosophy. Please note that this would be an arrangement or contract that would be between your agency and the individual practitioner. The County will not be involved in these arrangements.

The focus of Clinical Supervision in CCS is to develop and strengthen clinical skills and interventions of staff members, not to provide service plan recommendations that would be normally done through the consumers' treatment team. As a reminder, CCS Statute requires 1 hour of clinical supervision for 30 hours of direct treatment service. It is the responsibility of the contracted vendor staff to keep track of and report their own clinical supervision hours. It is recommended that the clinical supervisor also maintain a master log of supervision hours provided that is agreed upon when developing a supervisory agreement.
