RESIDENTIAL DROP-OFF AREA: \$5.00 minimum or \$120 per ton

MATTRESSES AND BOXSPRINGS	\$12.00 + weight
FREON ITEMS (Refrigerators, freezers, air conditioners, de-humidifiers, etc.)	\$12.00 + weight
SINGLE CAR TIRES (Up to 4)	\$8.00 each
HOUSEHOLD GARBAGE (Bagged waste, food, paper, plastic, etc.)	\$5.00 minimum or \$120 per ton*
METAL	\$5.00 minimum or \$120 per ton*
LARGE ITEMS (Furniture, toys, bikes, grills, stoves, dishwashers, lawn mowers w/o gas or oil)	\$5.00 minimum or \$120 per ton*
DEMOLITION/CONSTRUCTION DEBRIS (Wood, drywall, doors, windows, sinks, toilets, tubs, roofing, bricks, cinderblocks, flooring, etc.)	\$5.00 minimum or \$120 per ton*

PROCESSING PAD: \$5.00 minimum or a per ton fee

BLACKTOP/CONCRETE (Clean, no other debris)	\$5.00 per load
TIRES BY WEIGHT (Tractor, motorcycle, large truck, mower, UTV, etc.)	\$5.00 minimum or \$400 per ton*
SHINGLES (Clean, no synthetic tarpaper. No ridge vents)	\$5.00 minimum or \$40 per ton*
WOOD/PALLETS (Clean, untreated, unpainted, or stained)	\$5.00 minimum or \$35 per ton*
SAND, SOIL, LANDSCAPE ROCK (Clean, no other debris)	\$5.00 minimum or \$26 per ton*
BRUSH (Branches, shrubs, etc.)	\$5.00 minimum or \$35 per ton*
STUMPS OVER 18" DIAMETER	\$5.00 minimum or \$76 per ton*
YARD WASTE (Grass clippings, leaves, etc.)	\$5.00 minimum or \$51 per ton*

*1 ton = 2000 pounds

LANDFILL: Single use permit fee and \$64 per ton for in service areas. Single use permit and \$74 per ton for out of service areas. *In Service Areas include: La Crosse, Trempealeau, Buffalo, WI, Houston and Wabasha, MN*

ANNUAL PERMIT

\$300.00 per year, per vehicle.

3 DAY PERMIT

\$25.00 for 3 consecutive business days per vehicle.

SINGLE USE PERMIT

\$15.00 per trip, per vehicle.

•Unacceptable items taken to the landfill will have additional fees•

Utilization of the facility requires adherence to County Ordinance Chapter 15 and applicable Policies.
