## **RESERVATIONS / SAME DAY REGISTRATIONS**

1. Reservations may be made:

Online and via Telephone - with credit card only

In person - with cash, credit card, or check.

2. Reservations for campsites will be accepted beginning the 1<sup>st</sup> working day of each year.

> Reservations will be accepted for a minimum of two nights on weekends.

> Online reservations require a two-night minimum reservation regardless of the day of the week.

Online reservation can be made for up to 7 nights. Reservations for longer stays must be made via telephone or in person.

A reservation/campsite fee is for one camping unit on a campsite.

 A camping unit is e.g., one tent, one trailer or one motorhome. If a second camping unit can fit on a site, there will be an additional charge for the second unit.

- 3. HOLIDAY Reservations (Memorial Day, Independence Day, and Labor Day) require a minimum of three nights if the holiday falls on Friday, Saturday, Sunday, or Monday.
- 4. <u>A non-refundable reservation fee will be charged per reservation</u>. Same day registrations are not charged a reservation fee.

Reservations require Full payment of the camping fee plus the reservation fee at the time reservation is made.

- 5. Must be 18 years of age to reserve and register for a campsite. Registrant must occupy the campsite and is the person responsible for the campsite. If registrant reserves more than one campsite for the same period, the registrant will occupy one of the campsites and remains responsible for all other campsites reserved.
- 6. Campsite extensions:
  - a) Campsite extension done upon initial check-in is considered part of the original reservation/registration, must be on the same site and can only be done if site is available. Fees are adjusted at that time and must be paid in full prior to occupancy.
  - b) Extension requests received after check-in (site occupancy) are considered a new reservation/registration and will be processed as such. If site is available and intent is to re-register, this must be done prior to the 1 pm check out time.
- 7. <u>Switching Campsites:</u> You must call or stop at the campground office. Transferring or changing campsites cannot be done online.
- 8. Discounted rates for 7-day or 1-month rentals only apply when the entire stay is registered and paid for prior to site occupancy. No discounts apply if campers are paying day-to-day or if they reserve consecutive stays that eventually add up to 7-days or more.
- 9. Check-in Time: 3:00 p.m.

Check-out Time: 1:00 p.m. - site must be cleaned/vacated by this time to avoid an additional nightly registration fee.

10. La Crosse County reserves the right to make adjustments in assigning reserved campsites (i.e., flooding events).

## **CANCELLATIONS**

- 1. Cancellation requests must be made to the campground office and cannot be processed through the reservation system.
- 2. Cancellation requests 7 calendar days or less prior to the date the site is to be occupied
  - ➤ 50% of camping fees and reservation fee of \$8 is non-refundable
  - Applies to Nightly, Weekly and Monthly rentals
- 3. Cancellation requests 8 calendar days or more prior to the date the site is to be occupied -
  - Nightly and Weekly rentals: All monies except reservation fee of \$8 and cancellation fee of \$10 will be refunded.
  - Monthly rentals: All monies except reservation fee of \$8 and monthly cancellation fee of \$100 will be refunded.
- 4. No refunds will be made on cancellation requests received after the site is occupied.
- 5. **No Shows:** If you do not check in and occupy your reserved site by 1 pm on the last day of the reservation, you are considered a No Show. The campsite will be held for the entire reservation per check in/out times and there will be no refund of fees.
- 6. No refunds due to:
  - Inclement weather
  - Illness
  - Injury
  - Mechanical problems with vehicle and/or camping unit
  - > Family emergencies
- 7. **No refunds** for any fees paid for seasonal and Monthly campsite rentals.
- 8. **Flooding**: No refund will be issued if a like site can be provided with same electric/water amenities. If not, a full refund will be issued.
- 9. Refunds are processed by the La Crosse County Facilities Department downtown office. Refunds are issued to the original credit card used for purchase or via mailed check. NO cash refunds.
- 10. Any extraordinary circumstances requiring a decision regarding refunds will be made by the Parks Manager.
